This is with reference to your proposal no. IA/KA/IND/272431/2022, dated 01st June 2022 regarding the transfer of Environmental Clearance cited above mentioned project from M/s JaykayCem Limited to M/s. JK Cement Limited for the project mentioned above.

2. The Ministry of Environment, Forest and Climate Change (MoEF&CC) has examined the request submitted by you and the following points are noted:

- i. The Environment clearance (EC) to the project cited above was accorded by the Ministry vide letter no J-11011/489/2006-IA-II(I) dated 14th Sept 2007 in respect of Cement Plant from 2.20 MTPA & 2.50 MTPA OPC and Captive Power Plant (2x25 MW) and amended vide letter No. J-11011/263/2009-IA-II (I) dated 21st June 2010 for Expansion of Cement Grinding unit (2.50 MTP to 3.5 MTP) and amended vide letter No. J-11011/263/2009-IA-II (I) dated 21st June 2010 for Expansion of Cement Grinding unit (2.50 MTP to 3.5 MTP) and amended vide letter No. J-11011/263/2009-IA-II (I) dated 26st Sept. 2012 for change in product mix to manufacture cement based adhesive without increase in production capacity at Village Muddapur, Taluka-Mudhol, District-Bagalkot (Karnataka) for JaykayCem Ltd.
- ii. The Board of Directors of Transferor and Transferee have at their meetings held on 27.03.2009 has decided to make the scheme effective from 01.04.2008 and from the effective date, the Transferor Company has transferred the project to the Transferee Company and the Transferor Company is no more associated with the project.
- iii. No Objection Certificate (NOC) dated 22nd April, 2022 from transferor i.e., M/s JaykayCem Ltd in a non-judicial stamp paper for transfer of aforementioned

Environmental Clearance from M/s. Jaykaycem Limited to M/s. J K Cement Limited has been received.

- iv. The undertaking by transferee i.e., M/s. J K Cement Limited in a duly signed letter form has been received stating/committing that the company (M/s. J K Cement Limited) agrees for the transfer on the same terms and conditions under which prior Environmental Clearance was initially granted as per the provisions of EIA notification, 2006 in favour of M/s Jaykaycem Limited.
- v. The Corporate Identification Number (CIN) details of M/s JaykayCem Ltd and M/s J K Cement Limited is L17229UP1994PLC017199. Further, in the online application it has been mentioned that there is no change of Ownership.
