Sir,

The undersigned is directed to refer to your letter No. MDL/ADM/4103 dated 4th April, 2005 seeking permission from the Ministry to manufacture cement based adhesive for tile flooring.

- 2. The proposal was placed before the Expert Appraisal Committee in its meeting held during 24th 25th May, 2012. It is noted that company proposes to manufacture cement based adhesive for tile flooring by blending the existing plant products. No outside material will be purchased except a little quantity of solid polymer to improve performance of the product. The production capacity will not exceed 3.5 MTPA. The CO₂ per ton of product shall be 40-60% of normal cement. There will be no use of water and no effluent generation. No impact on air quality is also envisaged since the blending would be done in an enclosed area. The Committee recommended the proposal.
- 3. The Ministry accepts the recommendation of the Expert Appraisal Committee to manufacture cement adhesive for tile flooring subject to following conditions:
 - i. The overall capacity of the plant shall remain 3.5 MTPA.
 - ii. There shall be no increase in the water consumption and land requirement.
 - ii. The company shall comply with all the conditions stipulated vide Ministry's letter of even number dated 21st June, 2010.
- 4. In case of change in the scope of the project, fresh proposal for environmental clearance shall be submitted to the Ministry.
